




Texting while Driving Laws

Specifically prohibit the act of sending, reading, or writing text messages

Distracted Driving Laws

Cover any activities that divert attention from safe driving, include texting, , eating, using a GPS, adjusting a radio, and more.


Hands-Free Laws

Allow drivers to use their phones but only through hands-free technology.






Causes of Distracted Driving Accidents

California	\$150	\$250	\$500
Texas	\$100	\$200	\$300
Florida	\$120	\$250	\$500
New York	\$200	\$400	\$750
Illinois	\$75	\$150	\$300






Financial Impact of Distracted Driving






